



## DEPOSIT AND WITHDRAWAL OF FUNDS

You can replenish your account balance using one of the following methods:

- by payment card (debit or credit card)
- using the money transfer system WebMoney
- through Yandex.Money
- by direct bank transfer

Whichever method of replenishing the balance of the trading account on the platform you choose, the funds will be credited in US Dollars. This does not mean that it is necessary to transfer US dollars exclusively, setting currency accounts for these purposes. For replenishment, any currency can be used, the transfer will be converted into the platform currency automatically. Please note that the LLC VIPTRADE does not affect the terms of the conversion, the rate is determined by the financial services operator chosen by you.

LLC VIPTRADE does not impose a fee for accepting payments, regardless of the method and currency of replenishment of the trading account.

***We guarantee the security of payments.***

***Attention!*** As part of KYC's and AML's policy compliance, LLC VIPTRADE does not accept payments from dubious or unproven sources. The personal information specified when making the payment must match the information specified when registering the trading account. The client guarantees the veracity of the transmitted data.

- commission: 0.8% of the transferred amount

***Yandex money***

- the term of crediting funds to the trading account - 1-2 minutes
- commission: 0,5% of the transferred amount

***Bank transfer***

- the term for crediting funds to the trading account is 2-3 working days
- commission: check with your bank
- contact your personal analyst to obtain the requisites for the transfer

***You can withdraw funds from the trading account in one of the following ways:***

- by bank card (debit or credit card)
- using the money transfer system WebMoney
- through Яндекс.Деньги
- by direct bank transfer

***Withdrawal rules:***

1. LLC VIPTRADE does not set limits on the number of withdrawals from the trading account.
2. Effective bonuses are reset when you apply for withdrawal.
3. LLC VIPTRADE does not charge a commission for withdrawing funds from the client's trading account (except for the payment made by bank transfer).
4. The minimum amount of output is not fixed. An exception is the withdrawal by bank transfer.
5. Within the framework of following the policy of AML and KYC by the LLC VIPTRADE , when issuing funds, client identification documents may be requested.

6. When applying for withdrawal of funds, you must ensure that all conditions for accepting bonus funds on the Trading Account are fulfilled. Make sure that you have studied the rules for accepting bonuses in the Terms and Conditions and the Bonus Policy sections of this site.
7. The company reserves the right to request additional identification documents from the customer in the event that the withdrawal amount exceeds \$ 1,000.
8. To withdraw funds, you must use the way that the client chose when crediting funds to a trading account.
9. The application for withdrawal of funds is carried out through the functionality of a personal cabinet on the trading platform. The period for consideration of the application is from 3 to 10 working days (excluding the time during which the client sends the documents requested by the company).
10. If the Client submits any withdrawal request after depositing funds, without undertaking any trading activity, or if any other suspicious activity of the Client is detected, the Company has the right to:
  - a. Refuse to withdraw funds until the minimum turnover for this type of client's trading account is completed, but not less than 3 lots.
  - b. Charge 10% of the total amount withdrawn from the Client's Trading Account. The Client will be notified by email of the processed withdrawal request and the applicable fees for the specific case.
